
MEMORANDUM

SUB: Utilization of services under Bond in r/o UG pass-outs from ESIC Medical / Dental colleges – reg.

Pursuant to approval of the ESI Corporation at its 172nd meeting held on 4th December, 2017, the undersigned is directed to refer to the captioned subject and to inform as under:

1. Services of UG pass-outs(MBBS/BDS) from ESIC Medical / Dental colleges, including State Government run medical Colleges where admissions have been given under 'Insured Persons Quota' would be utilized, under Bond, as 'ESIC-Junior Residents (ESIC-JRs)' in ESIS/ESIC Institutions, i.e. Hospitals and Dispensaries, preferably under the supervision of senior doctors, as per ESIC Residency Scheme (JR). The details of ESIC Residency Scheme for compulsory service under Bond are enclosed as Annexure.
2. The States would have the first choice for their (UG pass-outs) utilization in the ESIS system. The willingness of the States to utilize the pass-outs at the given pay structure in the ESIS system, i.e. level in 7th CPC equivalent to 6th CPC PB-3 with GP Rs.5400/-, would determine the placement of these pass-outs in the ESIS system. In event of the unwillingness of States, the pass-outs would be placed in the ESIC system as the second step.
3. Under the scheme as above, (i) Director Medical Insurance Services (DIMS) of the respective States; and (ii) Medical Superintendents of the concerned ESIC hospital and Director (Medical) of the concerned ESIC scheme, in the ESIS/ESIC System respectively would exercise the powers of Appointing and Controlling Authority, i.e. for Classification, Control and Appeal (CCA) purposes.
4. Candidates not willing to render compulsory service under Bond will have to deposit an amount as per condition of Bond, in favour of **ESI Fund Account No. 1.**
5. Unsatisfactory conduct and performance during service would be construed to be 'non-performance of service' under Bond and attract penal provisions, including recovery of Bond amount.
